Sub: - Corrigendum to Recruitment Notice No: 95/ICDS/STI dated 24.03,2023

In reference to the subject mentioned above, it is hereby informed to all concerned candidates who appeared in the written examination on 29-04-23 and 36-04-23 for the posts of AWW and AWH that the reservation in Recruitment Notice No. 95/ICDS/STI dated 24.03.2023, is hereby amended by incorporating reservation for Economically Weaker Sections (EWS) as notified by the Labour Department, Government of West Bengal vide Notification No-18-Emp (EC)/LABR-27011(20)/01/2020-EC, dated 07/02/2023.

Therefore,

- 1. Unreserved category candidates belonging to EWS who appeared for the aforementioned exams will be required to update a self-declaration of their EWS status at www.coochbeharwb.in from 08/03/24 to 23/03/24 (up to 6 PM). Candidates are also advised to print the system-generated EWS declaration for future reference.
- 2. If any candidate does not update the EWS Declaration within the prescribed time period as mentioned above, it shall be assumed that she does not belong to the EWS category.
- 3. Subsequently, qualified EWS candidates shall have to produce the EWS Certificate issued by the competent authority at the interview stage during document verification. Otherwise, no claim in this regard shall be entertained.
